

Privacy policy

The website of Taleton Eco Guesthouse is owned by Taleton Eco Guesthouse. This company is the data controller of your personal data. The privacy policy outlines how we process the information collected by Taleton Eco Guesthouse and why we need to collect certain personal data about you. Therefore, please read this privacy policy before using Taleton Eco Guesthouse's website. We take care of your personal data and we will ensure the confidentiality and security thereof.

When you visit Taleton Eco Guesthouse, we automatically collect certain information about your device, including information about your web browser, IP address, time zone, and some of the cookies installed on your device. Additionally, while browsing the site, we collect information about the individual web pages or products you view, which websites or search terms referred you to the site, and how you interact with the site. We refer to this automatically collected information as 'Device Data'. Furthermore, we may collect the personal data you provide to us (including name, surname, address, payment information, etc.) during registration to fulfill the agreement.

Why do we process your data?

Our top priority is the security of customer data, and as such, we can only process minimal user data, only as much as is absolutely necessary to maintain the website. The automatically collected information is only used to identify possible cases of abuse and to establish statistical information about the use of the website. This statistical information is not aggregated in a way that could identify a specific user of the system. You can visit the website without telling us who you are or without disclosing any information that could identify you as a specific, identifiable individual. However, if you want to use some features of the website, or if you want to receive our newsletter or provide other details by filling out a form, you can provide us with personal data, such as your email address, first name, last name, city of residence, organization, phone number. You can choose not to provide personal data, but then you may not be able to take advantage of some features of the website. For example, you may not be able to receive our newsletter or contact us directly from the website. Users who are unsure about which information is mandatory can contact us at info@taleton.gr.

Your Rights:
